## ABOUT ORBS

Please check out your "orbs" completely before sending them to this department. If photography is done by digital camera, try enlarging the photo on your computer to see if there is a recognizable face. Give reason why you think it is spirit. Did you ask for confirmation of some sort that spirit would be present at a specific time? Explain in detail.

## INSTRUCTIONS

- 1 Physical Mediumship: Ectoplasm, Independent Writing/Voice, Slate Writing, Direct Voice, Luminous Appearances, Independent Spirit Painting, Planchette or Other Writings, Spirit Rapping, Materialization, Table Tipping, Transfiguration, Transformation, Trumpet, and similar type of mediumship.
- 2 Spiritual Healing that has brought about remission.
- 3 Write in the manifestation that was witnessed by others
- 4 A spirit message that has proven to include evidential information or prophecy, either at a church service or at a church Mediums Day event.
- 5 Indicate which type of this phenomenal evidence is to be reported.
- 6 Check for conclusive identification of spirit for trance mediumship.
- 7 Any other form of phenomena that is not listed.
- 8 The exact time would be helpful, but approximate time is okay.
- 9 Please present any description related to your event, including weather if outside, lighting in room if inside. Were you the only one present? There is never too much information; please let us worry about sorting it out. It is important that we understand the circumstances related to the event.
- 10 If you were attempting this in a class setting, please present what was done to prepare for physical mediumship. If the physical mediumship was spontaneous, please give details as they unfolded.
- 11 An example of a false positive would be a mirror flashback unknowingly used in photography and not taken into account, or lights angled in such a way to record as ghostly apparition.
- 12 Witnesses are very important. Please try to get enough information so that any future contact can be made, if need be.
- 13 Express your feelings about what happened, and what effects you feel it had on you and your witnesses.
